2020 Third Quarterly Board Meeting

The Louisiana State Board of Home Inspector's third quarter Board meeting was held September 11 2020 at the Board office in Baton Rouge. The meeting was also streamed via ZOOM.

The meeting was called to order by Chairman, James Yaeger at 9:05a.m.

The Board began the meeting with the Pledge of Allegiance followed by the Board members reviewing and approving the minutes of the previous Board meeting.

The Board reviewed and approved the In-field Trainer provider application for Ricky Thibodeaux of Lafayette LA.

There were three complaints on the agenda two of which were dismissed as the SIE found no probable cause for a hearing. The board did hear C-20-002 LSBHI v. LeBlanc.(see page 2)

The Board unanimously voted to extend the temporary rule change allowing home inspectors to receive continuing education credit for attending LIVE Streaming CE and have it count as "In-Class" credit throughout the COVID 19 recovery. This change is now extended until December 4, 2020. At that time, the Board will again assess the situation to determine if it should be extended or not.

Board Attorney, Nicaud gave a quick update on the matter of Mr. Thom-Kelting versus LSBHI. The matter went before the court on August 10, 2020 on appellant Thomas Kelting's petition for judicial review regarding the board's findings pertaining to C-19-001 Poche v. Kelting. The 19th JDC Honorable Judge William A. Morvant DENIED the petition and the ruling made by the board dated June 21, 2019 was AF-FIRMED.

The Board meeting was later adjourned by Chairman, James Yaeger at 10:30 a.m.

Disciplinary Actions from September 11, 2020

C-20-001 Ross v. LeBlanc LHI#10628- SIE found no probable cause, complaint was dismissed.

C-20-002 LSBHI v. LeBlanc LHI#10628– Mr. LeBlanc was present and sworn in by Chairman, James Yaeger. Mr. LeBlanc admitted that he failed to report monthly reporting due to technical/computer issues. After hearing testimony the Board stated that Mr. LeBlanc should have found a way to report monthly regardless of the computer issues finding him in violation of LAC46XL.17B-failing to submit monthly reporting for over a year. The Board found that Mr. LeBlanc failed to notify the Board of his address change and contact information in violation of LAC46XL.133A– failing to notify the Board of his address change. The Board levied a fine of \$3120.00 for violating LAC46XL.117B and \$300.00 for violating LAC46XL.133A. Total fine:\$3420.00

C-20-003 Thompson v. Naquin LHI#10951- SIE found no probable cause, complaint was dismissed.

Live Streaming CE


The Board unanimously voted to allow home inspectors to receive continuing education credit for attending LIVE Streaming CE and have it count as "In-Class" credit throughout the COVID 19 recovery. This change is in effect until December 4, 2020. At that time the Board will reassess the situation to determine if it should be extended or not.

LIVE Streaming Rules:

Class size is limited to 25 participants Each participant must use video (no blank screens allowed) and must participate Each class is limited to 2 hour blocks with a maximum of 6 hours per day.

LIVE streaming should not be confused with online CE. Online CE* is still limited to 10 hours of CE per licensing period.

All LIVE streaming courses will be broadcast by the LSBHI as well as listed on the calendar which can be found on our website.

Board Members Term Soon to Expire

The term for the board members representing **congressional district no. 3 and no. 4** will expire March 2021. The board shall be composed of one member from each of the six congressional districts and one at-large board member that can be drawn from any of the congressional districts. Each member is appointed by the governor from a list of nominees submitted by the board of directors of the Louisiana Chapter of the American Society of Home Inspectors, the Louisiana Realtors Association, and the Louisiana Homebuilders Association. Each member of the board shall serve a four year term. Each member shall have been actively engaged in the home inspection business on a full-time basis for three years preceding the appointment.
